# **Caretaker Report:**

#### Old Business.

<u>Camping Fees.</u> Committee members and the three grottos are OK with the new fees.

Grotto tour guides camp for free.

Electric sites, additional \$5 per night.

Camping Pass. Individual, \$30.00/yr., Family, \$50/yr.

Memorandum of Understanding. During the past few months Neena, with input from the GSP management committee, RKC and GCG has reworded much of the MOU to clarify the responsibilities and duties of the relationship between Rockcastle Karst Conservancy, Inc. and The Greater Cincinnati Grotto.
