Website:

The NSS is updating their website, and is getting rid of their server in favor of having the website hosted by someone. They revised layout will be a wordpress template. Any new websites (like the GSP website) may need to be a wordpress layout. The new server will be up by April. The new server will only host NSS IOs and Conservancies. GSP is no longer a conservancy, so GSP may not be able to host their website there. GB is searching for answers. GCG is acquiring a new hosted server, which hosts GCG, KoR and RKC. Should they host the GSP website and share the cost (which is currently \$13 per year). The estimated cost is \$49 per year, which includes a security certificate. This would also allow us to have our own domain.

PG asked if the NSS would be willing to add a redirect to the new website. GB said they probably would.

Werner promised to raise Gary's pay by 3 times.

WJ motioned to proceed with Gary's suggestion of going to a new host. SP second. The motion was unanimous.

FB made a motion to purchase 300 stickers, or whatever gets a price break. NJ seconds. Passed unanimously.
