Wi-Fi

Werner Jud reports PRTC has run the lines to the property, including a new pole about 1,000 feet past Edna's house because the old pole was too low to have another line crossing the road. We have 2 new service drops, one by the caretaker's residence and one by the ticket house.

Patrick Gibson asked if the installation will be free. Werner reports it is not, there will be a nominal fee to install. The work they have done so far is at their expense.

Installation and hookup is likely to be postponed until the water line leak discussed below is resolved.

New Business

Werner, Jerry, Jared and Josh investigated and discovered it must be between the meter (on 1004) and pressure regulator 2 (on the Sara Corrie* Trail). It is losing about 12 gallons an hour, which led to a 3,000-gallon overage on the last bill representing about 10-12 days of leaking at about 12 gal/hour. If not fixed, and if it stays the same rate, it will be about 9,000 gallons on the next bill, which should put the bill around \$75, about triple for this time of year. This will need to be repaired when it warms up. Ultimately, we need to replace the old pipe; it is a 23-year-old thin wall crestline black pipe. The Senior Field Manager for Kentucky American Water (Rodney Trowbridge) is psyched up to take this repair on. Werner would like to replace (and upgrade) the line with 2" bluewall pex and replace Regulator No. 1. Werner will meet with Rodney and an associate at the property next week to review and advise. More information to come.

*Note this is the way her name is spelled. There is a Sara Corrie NSS memorial fund.

Gary Bush reports that there could be issues with people joining the meeting with the reoccurring link. He also brought up the possibility of Zoom bombing meetings. Discussion ensued. We will burn that bridge when we get to it.
