# Secretary's Report

Fred Ball made a motion to accept the September meeting minutes as distributed. MS seconded.

#### **Treasurer's Report**

Income exceeded Expenses in the month of October due to lots of activity. *Full report available upon request.* 

FB moved to approve the Treasurer's report, JB seconded. No objections.

#### **Caretaker's Report**

Kristen is in Louisiana, due this weekend so Werner provided an abbreviated report. This week he arrived on Tuesday, installed new gutter guards and additionally tightened all the roofing screws and worked on other CR maintenance items.

## Sub-committee Reports

#### **Miscellaneous Property Maintenance**

- Caretaker's Residence
  - Replacement window screen was installed for master bedroom.
  - Exterior lights completed with anti-glare shields.
  - Master bath vanity/counter replacement Kristen said it is fine as it is don't mess with it.
  - Plumbing upgrades underneath the building in crawlspace ongoing, Werner could use help

- Drywall installed in the Bathroom. A section still needs replacement at the phone (further installation & finishing postponed until Spring).
- Waterline PR3 Replacement Werner Jud
  - Summary: The new main water shut off and PR3 assemblies have been installed. Before freezing weather arrives, the excavations must be backfilled and gravel added to the bottom of the PR3 pit. We also need to excavate for the new CR shut off valve and tab meter. Rodney is providing this at no additional cost.
  - Please see email dated 11-2-2024 from WJ on this topic for full report, attached.
- Tractor repair still anticipated now hoping for second week of December Scott Pavey
- Ticket house renovation Werner Jud/Scott Pavey/Jerry Brandenburg No change since last meeting. Werner & Neena plan to install a dust protective membrane on the ceiling joists this weekend.
- Lights in the Cave A few lights and sockets in the Cave still need to be repaired. Also, some bridge planks at the Russian Dome need to be replaced. Kevin Lorms, while trying to conceal wires with additional rocks, noticed a wire near the north entrance with insulation that had been significantly gnawed on by mice.
- Atlas Pillar Electric Panel Replacement no change since last meeting Werner Jud has researched panel options.
- Utility pole outside of the Cave no change since last meeting requires installation of new support plywood for service drop, meter and main 200 amp panel. Material is on site, one piece has been cut to size, the other side needs to be cut and both need to be installed. Two or three people can complete this in a day.
- Shower House Roof re-shingling completed.
- Locks & Gate Combo
  - Werner has sent the letter to Vendors.
  - Debi has sent the letter to managing grotto chairs.
  - We have the second key lockbox for use in the Shelter to house the rescue box key.
  - The key lockboxes for the Tractor Barn and Kitchen will change combinations.
  - All these will change during the January meeting on site.
  - Debi needs to write an email to managing grotto chairs about loaner keys.
- WiFi Patrick Gibson no change since last meeting
  - Patrick will prepare an instruction sheet on how to make phone calls over the internet on individual cell phones (VOIP) and post it at the Shelter.
  - There has been a phone in the mailbox at the CR for emergencies. We will still add a sign in the Shelter directing people to it.
- Cameras Dan Zubal
  - Debi spoke with Dan and found out that he has still not ordered them.
  - It was decided to delegate this to someone else. Mark will discuss this with Patrick. Fred is willing to assist. Keep Kristen in the loop.

## New Business

## Cost of garbage pick-up

- After receiving notice that Bee Garbage was going to raise dumpster rental rates, Werner wrote a letter to them requesting they honor the dumpster rental payments we've made through the end of the year.
- Today when WJ took bags of garbage to the dumpster, he was surprised to see that it was nearly full already. He recommended that people collapse or cut up boxes so we are not filling the dumpster with air.
- Darryl suggested asking folks to not throw out bulk items (boxes, tents, random appliances) at the Preserve, but haul that stuff home. Only bags and recycling.
- Werner shared an idea from Kristen make our own trailer to transport our trash directly to the dump in London. She also suggested sharing responsibility between all four grottos to haul it when full. Bee Garbage charges \$3/bag when dropped off with them. This might be less cost than what we are currently paying. Discussion ensued, until we acknowledged that we have a hard enough time getting people to volunteer for what we currently have going on.
- Maybe it is time to raise camping rates again. Debi shared for comparison that primitive camping in the Daniel Boone National Forest is \$20/night. For electric sites and access to water is \$35-40/night.

- Werner offered to prepare a budget spreadsheet comparing the last three years of income and expenses and projecting the next year's expenses. He will send this out prior to the next meeting so it can be discussed then.
- FB will likely make a motion next month to raise camping rates anyway.
- WJ suspects that we do not recoup enough for electric usage. The Camping passes state electric is not included. We could change that to red type.
- Suggestion made to place signs at the Mondos and electric sites that electric usage required additional fees. We can use the QR code there as well. These signs need to be weatherproof.
- Encourage donations for Day use as well since Port-O-Lets and the electric & water at the Shelter gets used.

We have over 4000' of waterline that runs underground from our meter on 1004 Big Cave Road, to all our points of use: Caretaker home, a branch line to the electric campsites, shower house, tractor barn, the shelter kitchen.

I am very pleased to report that the 3<sup>rd</sup> and final upgrade was completed last week during Monday and Tuesday evenings. Jerry B. and I were present as the main 2" shut-off valve to the property and the nearby PR#3 (Pressure Regulator #3), were entirely replaced with commercial duty, waterworks grade components. Designed and built to last (hopefully 50 years) this project is 90% complete, and immediately resulted in a much need pressure drop at the shower house.

There is follow-up work to do and it will need some volunteer labor in the next 30 days; <u>but most certainly before freezing</u> <u>temps return</u>. The dirt removed early September can now be backfilled around the two new enclosures. The white one is for the shut-off valve and the larger black one surrounds PR3 assembly. We also need to add some gravel to the PR3 location to facilitate better drainage should water accumulate at the bottom. We have plenty of gravel for this piled in the upper parking lot. This needs to be done with care so as not to damage the assembly.

Finally, as a no-extra-charge bonus, Rodney will provide an upgraded shut-off valve (with an added flow meter) to replace the old shut-off dedicated for the CR. It is located in the grass where we typically set-up KOR registration and is marked by a couple of small blue flags. To prepare for that we need some folks with shovels to excavate this location, remove the old plastic enclosure and dig out enough extra dirt so a new enclosure can be set in place flush to the ground after the parts are installed.

I hope to return to GSP soon for these chores, as well as other on-going needs for the ticket house, cave, and shelter kitchen. Help is needed to expedite the work. I will review all this at the next GSP meeting so we have the information in our meeting minutes. Werner
